

## AGOSCI In Focus Publication Consent and Release Form

AGOSCI In Focus is a magazine produced in print and online.

We want to ensure that consent is provided by or on behalf of all people directly written about or shown in images in the magazine. We acknowledge that people should be able to have their name used in stories or photos or remain anonymous. Some people may wish to have their image in the magazine but have their face obscured, while others may be happy to have their entire photo used.

We recognise that some people can provide consent on their own behalf. Some people such as children under the age of 18 or adults with severe cognitive impairments may be unable to provide full consent. They will require consent to be given by a next-of-kin or officially designated consenting other (e.g., guardian).

AGOSCI supports the practice of supported decision making, and any such decisions should be made in consultation with the person to the maximal extent possible (e.g., showing them the magazine, the photos, draft manuscripts).

This is a consent form for all people written about or presented in images in AGOSCI In Focus. It should be completed by the contributing author with the people in the manuscript and submitted to the editor.

### Author checklist

- Author provides consent for their own name to be used as the author and a contact email address
- Ask the person and/or the consenting person if they want to be in your article
- Ask the person and/or the consenting person if they want their name (first, last, pseudonym or no name) to be used in your article
- Ask the person and/or the consenting person if they want their photo used in the article (full face photo, photo obscuring face, or no photo)
- Complete the consent form and forward to the editor.
